CALL FOR PUBLIC COMMENT ON ANY AGENDA ITEM TO BE VOTED ON IN ACCORDANCE WITH ACT 850 OF 2010. NO PUBLIC COMMENTS AT THIS TIME; HOWEVER MR. ARCENEAUX INTRODUCED DR. CHARLES BURNELL AND MR. TROY GUIDRY WITH ACADIAN AMBULANCE.

MOTION MADE BY MR. TURNAGE AND SECONDED BY MR. SPILLER TO ADOPT THE MINUTES OF THE RPCD BOARD MEETING HELD ON JANUARY 12, 2022. ALL IN FAVOR, MOTION CARRIED.

THE NEXT ITEM WAS THE DISTRICT ACTIVITIES REPORT; ALL BOARD MEMBERS WERE PROVIDED A COPY PRIOR TO TODAYS MEETING. MRS GREMILLION UPDATED ON THE STATUS OF THE WEBSITE AND THEN MOVED ON TO THE NORTH SIDE FIRE CHIEF MEETING THAT WAS HELD THE PREVIOUS WEEK TO WORK ON FIRE DEPT PROTOCOLS. THIS MEETING INCLUDED 4 FIRE CHIEFS, MR. SPILLER AND MR. TURNAGE AS WELL AS SEVERAL OF THE RPCD EMPLOYEES. BRIEF OVERVIEW WAS PROVIDED BY MRS. BRANTON NOTING THAT PROTOCOLS TO ENSURE CONSISTENCY AS WELL AS EFFICIENCY ARE BEING WORKED OUT. MRS. GREMILLION IS GOING TO BE MEETING WITH MR.
